### ☆ ☆ FLORIDA — Director William J. Richards

A dinner meeting was held on November 27 with 23 members and nominees present. Dean Warren S. Wooster of the Rosenstiel School of Marine and Atmospheric Sciences (RSMAS) of the University of Miami spoke on 'El Nino' and the collapse of the Peruvian anchovy fishery.

The need for good environmental data was emphasized as in the belief of the speaker the vagaries of El Nino were more important than overfishing in causing the collapse.

In January at a dinner meeting attended by 21 members and prospective members, Dr. Hans Ackefors, Director of Research at the Institute for Marine Research, Lysekil, Sweden spoke on "Overfishing and Management" in the Northeast Atlantic.

The District vigorously supported the effort of the Governor of Florida to appoint a well-qualified professional as Executive Director of the Department of Natural Resources. Though the effort failed by a 4 to 3 vote of the Cabinet, the District was at least gratified by the close vote.

### SOUTH CENTRAL GREAT LAKES —

#### Director Stanford H. Smith

A seminar series with the theme of *The Future* got off to an enthusiastic start with Sandy Engel and Tom Edsall Joint Program Chairmen. Project topics were:

January; The Future of Water Quality Standards and their Impact on Fisheries.

February; Power Production and Related Problems in the Great Lakes.

March; Nutrients, Plankton, and the Great Lakes — A 'Loaded' Problem.

In the Fall of 1973, the District held a dinner meeting to discuss District and National activities and objectives of the AIFRB. A Steeering Committee under Carlos Fetterolf tackled the question of District organization with a view of expanding activities throughout the District.

Howard Johnson is serving as Deputy District Director responsible for activities in the Northern sector of the District.

advanced in rank.

Drafts of a District Resolution on logging practices and a 'white paper' on genetic aspects of salmonid management were circulated for comments.

### DOINGS IN WOODS HOLE

Three AIFRB members with the NMFS at Woods Hole have been very active in international research matters.

Dr. Emory D. Anderson presented assessments of the New England mackerel and red hake stocks to the Assessments Subcommittee of the International Commission for the Northwest Atlantic Fisheries in Hambugr in January, 1974.

Dr. Eugene G. Heyerdahl participated in an ICES Flatfish Working Group in Copenhagen and was in Poland to discuss

joint U.S.-Polish research programs.

Dr. Jerry Reeves presented two papers to ICNAF, one, a simulation study comparing yields from catch and effort quotas with variable recruitment, and a cost study of surveying recruits to the Georges Bank herring fishery.

Albert C. Jensen - Fellow AIFRB 224 pp - \$7.95 - The Crowell Co.

This volume presents a comprehensive statement on the Codfish and on the impact it has had upon American life for the past 1000 years. It is a concise and readable document.

GUIDE TO MARINE FISHES OF CALIFORNIA Daniel J. Miller and Robert N. Lea

235pp - \$1.84 - Cal. Dept. of Fish and Game Robert N. Lea, member of the AIFRB and co-author Daniel J. Miller published in 1972 (Dept. Bull. No. 157) a valuable illustrated guide identifying 554 species of shallow water marine fishes in California. This is a must for any one interested in the fish of the Pacific Coast.

**AQUACULTURE** 

John E. Bardacsh, Fellow AIFRB; John H. Ryther; and William O. McLarney

868 pp — \$37.50 — John Wiley & Sons

This is monumental and encyclopedic. It provides the first worldwide, species-by-species review of all aquatic plants and animals cultivated for food, and includes the methodolgy involved.

- 3. INTERNATIONAL SCIENCE AND ENGINEER-ING AWARD — \$100.00 for the best fishery-oriented exhibit by a student.

Members who qualify under the Bylaw quoted below may request EMERITUS status if they so desire. Please advise in the enclosed envelope.

Section 8-Designation of Emeritus Fellow and Members

The Board of Control may designate as Emertius Fellow or Member, any scientist who, having been a member in good standing for at least five years, (a) shall request that status, having by reason of age retired from professional employment in fisheries biology, or (b) has been eminent in fisheries biology or has become active in other fields. Emeritus Fellows or Members shall be privileged and requested to take part in all activities of the Institute, shall not be required to pay fees or dues, and shall not hold office or vote in the election of officers, or in the amendment of the Articles of Incorporation or the Bylaws. A unanimous vote of the Board shall be required for such designation.



## In Memoriam RONALD WARD CRAWFORD

It has lately come to our attention that our colleague Dr. Crawford who was a member of the Institute since 1964 passed away somtime ago.

Dr. Crawford was Chairman of the Department of Zoology at San Diego State College, San Diego and had a long and successful career in the field of University teaching. He was also active in the consulting field involving biological and resource management studies.

#### JOHN LAWSON HART

Dr. John L. Hart noted Canadian fisheries biologist passed away recently at the age of 69. .

Dr. Hart was a Founding Fellow of the Institute and in 1961 became the first President of the Institute after W. F. Thompson, the original Incorporator.

The professional career of Dr. Hart covering a span of nearly 50 years epitomizse so well what the Institute stands for — Achievement and Excellence. He also had the distinction of having been Director at different times of the Pacific and later the Atlantic Research Stations of the Fisheries Research Board of Canada.

A few months before his death he had the satisfaction to add to a long list of publications his latest achievement, THE PACIFIC FISHES OF CANADA.

Though not to detract from the original Clemens and Wilby edition this revision will be known for generations as the 'Hart Book' on the fish fauna of the Pacific Northwest.

John Lawson Hart's passing is a great loss to his friends and colleagues in the United States and Canada.

### **EXCELLENCE RECOGNIZED**

DEAN E. ARNOLD, presently Assistant Leader, Cooperative Fishery Unit. Pennsylvania State University wins the 1974 W. F. Thompson Award for the outstanding student publication of the year;

### **EXPERT TO THE COURT**

Richard R. Whitney, FELLOW of the Institute and Director of the Northwest Washington District has been appointed by Judge Boldt, U.S. District Court, to be Technical Expert to the Court in its continuing jurisdiction in the Indian Treaty Rights fishing issue.

Dr. Whitney is Leader of the Washington Cooperative Fisheries Unit. It is a signal honour for him and for the Unit as well as for the Institute for Dr. Whitney to be selected for such an assignment.

#### ACHIEVEMENT

Elbert Halvor Ahlstrom, Senior Scientist with the National Marine Fisheries Service at LaJolla, California and FELLOW of the AIFRB since 1960 was presented on October 25, 1973 the GOLD MEDAL of the United States Department of Commerce.

This is the highest honor conferred by the Department and was granted in recognition of Dr. Ahlstrom's classic studies in the field of stock assessment by means of systematic surveys of eggs and larvae.

### **NEW EDITOR BULLETIN OF MARINE SCIENCE**

William J. Richards, Director of the Florida District was recently appointed Editor of the Bulletin of Marine Sciences by Dean Wooster of RSMAS, University of Miami.

Dr. Richards is with the National Marine Fisheries Service. His appointment thus brings that agency into close cooperation with the University.

He announces that the Bulletin is lifting the former restrictions on papers on solely economic or applied fisheries. He also invites papers dealing with tropical or subtropical waters of a biological nature and with disciplines relevant to marine biology for Vol. 25, No. 1 which will appear in January, 1975.
